Upon acceptance of appointment as Ensign, USNR-R,
1. You will proceed and report to the District Medical Officer, Room 1404, 90 Church Street, New York, N.Y. for physical examination including flight physical in the case of aviators. Examining activity is requested to comply with the provisions of ALNAV-57. You will report for physical examination on any week day, Monday through Friday, inclusive, and NOT LATER than 0900 in order to complete examination in one day.

You are hereby ordered to temporary active naval service for this purpose and will be considered in a temporary active duty status during the time required for physical examination and for travel necessary for compliance with these orders. If found physically qualified or if a conditional waiver is granted by examining activity and later a review of your complete medical record by the Bureau of Medicine and Surgery indicates additional defects should be waived, the Bureau of Naval Personnel will automatically waive same, unless you are not considered physically qualified to perform duties assigned. In that event the unexecuted portion of your orders will be canceled.

2. If found not physically qualified (for Service Group One in case of aviators), you will immediately return to the above address and upon arrival consider yourself released from temporary active duty and forward a copy of these orders with all enclosures to the Naval Reserve Officer Performance Recording Activity, Naval Personnel Center, Omaha, Nebraska. In this event, the examining medical officer will advise BUPERS by message referencing these orders, stating defects in detail together with action taken and recommendations, if any, with information copies to BUMED and CC addressees on this order.

3. Upon reporting for active duty at the first naval activity required by these orders, if there has been any pronounced change in your physical condition or if more than 45 days have elapsed since the date of your last physical examination, you will continue on temporary duty at that activity, pending the completion of a substantiating physical examination to verify your fitness for active service. The examining medical officer will make suitable entry as regards the substantiating examination on NAVMED H-8 of the health record with a copy to BUMED. The commanding officer of the examining activity will grant a conditional waiver if required and not previously granted providing you are considered physically qualified to perform the duties to which assigned. If found not physically qualified to perform duties to which assigned the provisions of paragraph 2 will be complied with. If found physically qualified you will carry out the remainder of your orders.

4. Pay and allowances are chargeable to MPN, open allotment 10600, expenditure account 71110. Cost of travel is chargeable to MPN, open allotment 30600, expenditure account 74110, object class 029. Travel via private conveyance is authorized unless orders specify a period of duty less than 90 days

5. If found physically qualified, you will immediately return to the above address and upon arrival consider yourself released from active duty until such time as is necessary to proceed and report to the Commanding Officer, USS ABBOTT (DD-629), Newport, Rhode Island, on or before 30 April 1953 for active duty.

6. You are advised to make no personal plans for active duty until found physically qualified and not to move dependents until you have reported for duty and have definitely obtained suitable quarters for them. Copies of orders shall be forwarded in accordance with BuPers Circular Letter 115-51, Navy Department Bulletin of 31 July 1951, 51-543.

7. Acknowledge receipt of these orders to the Commandant, THIRD Naval District.

8. Your Officer Service Record is forwarded herewith. Your Health Record may be obtained from the District Medical Office.
